SCOPE OF WORK

A 240L wheelie bin including delivery at no additional cost, based on the following terms:

- The bin will be stored in a secure place inside the client's property, except on collection day.
- The bin remains the property of Izak Vorster.

Once per week the bin will be collected on the following terms:

- Collection will only be done on Saturdays after 15:00 (we will send you a reminder of this every Saturday morning)
- The bin must be placed on the sidewalk outside your property before 15:00.
- A clean bin will be dropped off and the full bin will be taken away.
- Only waste (as specified below), inside the bin will be collected.

PAYMENT TERMS:

Payment is in advance for the month to come (this helps us to avoid a deposit and fees)

- A 240L green wheelie bin will be delivered after the first month's payment has been received.

- Payment can be made in cash or electronic funds transfer.
- Payment must be received before the first Saturday of every month.

Allowable waste:

We make organic compost for our vegetable gardens with the waste, so please stick to the rules of what can be thrown into your bin:

- ✓ Any plant-based kitchen waste (any leafy greens, vegetable peels, eggshells, spent coffee grounds, brown cardboard boxes, brown paper bags, etc)
- ✓ General Garden waste, grass clippings, weeds, trimmed leaves, fallen leaves.
- ✓ Scrub and tree pruning's with stem diameter not exceeding 20mm in diameter that fits into the bin. Please prune them short enough to fit into the bin.

Not allowed in the bins:

- ✗ No animal products (Meat, fat, fish, milk, or any milk products)
- ✗ No organic matter that has been treated with any chemical herbicide or pesticide (Roundup, weed killer etc.)
- ✗ No dog/cat poop please.
- ✗ No rocks, bricks, concrete or soil.
- ✗ No plastic, steel, aluminium, or construction wood.

Terms and Conditions:

- Damaged or stolen bins will incur a replacement fee of R750.
- Collection will not be done on rainy days, but alternative plans will be made.
- A penalty fee of R50 goes directly to the guy cleaning your bin if non-allowable items are found (see above).
- There will be no refunds if a bin is not being put outside by 15:00 on a Saturday.
- You will be added to a WhatsApp Broadcast group for communication.
- If payment has not been received by the first Saturday of the month, your bin will be collected and kept until payment has been made.
- In the case of ORGANIBIN (Pty) Ltd not being able to fulfil this agreement for any reason whatsoever, the remaining fee for the month will be refunded and wheelie bins will be collected (for example, death, disability, disease)
